## Process Details

The fresh peads are harvested and delivered to the factory on bulk bins. After QC checks, the peas are washed, inspected, colour sorted and blanched. After final inspection and metal detection, the peas are added to the cans with the brine, sealed and processed. After cooling, the cans are stored unlabelled. After incubation and final QC checks, the cans are labelled and packed.
