Product Description: A slice of roll of biscuit crumb, cherries and marshmallows bound together with condensed milk and rolled in coconut.

Product Characteristics: The roll of fifteens to be approximately 4-5 cm in diameter and cut into slices approximately 1cm thick. The diameter of roll being even along the whole length. The marshmallows and cherries to be evenly distributed in mixture and the coconut to fully cover the outside of the roll.

Shelf life: To be retained in sealed tray for up to 33 days.
